A comprehensive plan will be developed to implement key changes and communicate to our teams and stakeholders.

Empowering Future Generations

We aim to incorporate cultural activities and learning opportunities on country for young men and women. These initiatives will provide a platform for both to actively participate in and benefit from NQLC's work. We encourage our Members to consider ways to involve the younger generation, fostering a deeper connection to native title and our shared heritage.



AIATSIS Summit June 2024

In early June, the Board and staff had the privilege of attending the AIATSIS Summit in Narm. A pivotal event that brought together Aboriginal and Torres Strait Islander Elders, leaders, youth, and a diverse range of stakeholders. As one of the largest conferences dedicated to First Nations peoples, the summit offered valuable opportunities to support and strengthen our cultures, knowledge, and governance. The program included a three-day native title component and various discussions throughout the week on Indigenous research. I was particularly inspired by the keynote addresses from Jamie Lowe, CEO of the National Native Title Council, who delivered the Mabo Lecture, and Justin Mohamed, Ambassador for First Nations People. Their contributions highlighted the summit's significance in advancing our collective goals.

OPERATIONAL UPDATE



The Enterprise Agreement is a key instrument covering employee work terms and benefits. The process to negotiate a new EA has been a collaborative effort, between Bargaining Representatives from the Community and Public Sector Union and Non-Union Representatives, the Executive Management Team and an external Advisor from Coopers Grace Ward. The review actions of the EA19 was overdue. The goal of the new EA24 is to balance employer terms with the needs of our employees. A higher aspiration is to make the NQLC an Employer of Choice. AusIMM Conference

By engaging with industry leaders and experts, we aim to ensure that NQLC remains active in supporting our members, by identifying opportunities and helping to bridge any gaps within the sector. All new knowledge will help to shape our future plans and maintain strong advocacy for our members.



Celebrating CLCAC 40 Years!

Director Akee and CEO were fortunate to attend the 40th Anniversary of the Carpentaria Land Council Aboriginal Corporation (CLCAC). Formed in 1982 and incorporated two years later, CLCAC acknowledged its early history as part of NQLC. At the ceremony CEO presented a commemorative plaque to Murrandoo Yanner who accepted the gesture on behalf of CLCAC. Today CLCAC represents nine southern Gulf Aboriginal language groups and operates as a Native Title Service Provider. Their significant contribution includes their role in the landmark High Court case Yanner v Eaton (1999), which set a precedent for protecting hunting rights for Indigenous people. NQLC is proud of our association with CLCAC and look to future working opportunities.

Stakeholders from across Australia gathered in Burketown to celebrate CLCAC's achievements and honour its founders. Dir Akee and I had an amazing night, celebrating this major accomplishment with CLCAC and witnessing the enduring strength and spirit of the community.

HISTORIC WIN FOR JIRRBAL PEOPLE



In an eagerly awaited victory for the Jirrbal People, on 6 September, the Honourable Justice Rangiah of the Federal Court of Australia handed down a determination of native title by consent in relation to part of the Jirrbal People #4 (QUD983/2015) native title claim (the Part A Determination).

The Jirrbal #4 claim, submitted in 2015, encompassed a vast 279,904 hectares of land and waters in the Tablelands Region of Far North Queensland, brimming with cultural significance and natural beauty. The Part A Determination recognises the Jirrbal People as the rightful native title holders of the determination area in Australian law.

The Part A Determination secures exclusive native title over 9,797.53 hectares, and non-exclusive native title over 72,517.2 hectares of lands and waters of the traditional estate of the Jirrbal People.

The Wabubadda Aboriginal Corporation RNTBC (ICN 7117), which is the prescribed body corporate (PBC) for the previous three Jirrbal determinations, was nominated and determined as the PBC for the Part A Determination area and will manage the determined native title rights and interests on behalf of the Jirrbal People.

Though parts of the Jirrbal #4 claim area remain on foot in the Federal Court, and there is still work to be done, this determination is nevertheless a significant achievement for the Jirrbal People and in particular for their Elders past and present. The NQLC is planning to organize a celebratory event later this year to mark this achievement and the invaluable contributions of the Jirrbal Elders. Details will be unveiled as plans unfold.


MANBARRA LAY EVIDENCE ON COUNTRY



In late August and early September, a team from NQLC's Cairns and Townsville office, commenced a two-week journey around Manbarra Country for a deeply engaging lay evidence project. The purpose of the trip was to collect personal accounts from Manbarra Traditional Owners, adding crucial firsthand perspectives to bolster the Manbarra People's native title claim.

On the islands around Palm Island and out to the reef, our team had the privilege of engaging directly with Traditional Owners on Country. These conversations resonated with stories of heritage and the enduring connection to the country. Manbarra Elders and Traditional Owners graciously shared personal insights, memories and stories recounting what they have seen, heard and lived on their ancestral lands.

The Manbarra claim is notable as the first land and sea claim to be filed in the Federal Court by NQLC, covering an extensive area of immense cultural and spiritual significance. Our team's journey led them to sites of profound cultural importance, deeply respected by the Manbarra Traditional Owners. It was a rare and cherished opportunity to explore these places that embody their rich heritage. Each location revealed a unique story, from Dreaming tracks to sacred sites that have long served as sanctuaries for the community's totem animals.



A standout moment of the trip was the opportunity to listen to creation stories and Dreamtime narratives from the Elders and Traditional Owners themselves. These stories, rich with history and cultural significance play as vital threads in the fabric of the Manbarra Peoples enduring connection to their land. As the Elders spoke, their passion and pride were evident, with each story offering a powerful reminder of their deep-rooted heritage and the ongoing journey to preserve and pass on this vital knowledge to future generations. Witnessing their passionate storytelling was a moving testament to the strength and continuity of Manbarra culture.

The stories and testimonies gathered will be instrumental in advancing their native title claim, highlighting the enduring connection that defines their identity. We extend our sincere gratitude to the Manbarra People for their generosity in sharing their history, guiding us through their country, and retelling the journey of their ancestors. We acknowledge the Manbarra People for their unwavering commitment and invaluable contributions, which are vital in the pursuit of justice and rightful recognition of their people and country.

All interviews and stories were recorded with the explicit consent of participants, ensuring that the process respected and preserved the integrity and autonomy of the Manbarra People.

EDST UPDATE



This year is flying by, and the Engagement and Development Support Team has been busy. The FAME Unit and PBC Support Unit collaborate closely to achieve real outcomes for NQLC clients through their PBCs.

One key project involves working with three PBCs to combine resources and establish a partnership corporation to compete for large contracts through Supply Nation. EDST is managing the project, engaging Terri Janke and Co. to establish the corporation and KPMG to find suitable joint venture partners. This effort creates real opportunities for economic development and self-determination from native title. Native Title Act Future Acts Regime Review

The Australian Law Reform Commission (ALRC) has commenced a review of the future acts regime of the Native Title Act. NQLC FAME Unit has met with the ALRC initially to express NQLC's concerns about the functionality of the regime and to ensure NQLC's views are taken into consideration before the publication of the consultation paper. Large Negotiations and ILUAs

Negotiations for large projects, like renewable energy and mining, often begin with a section 29 'right to negotiate' (RTN) or an ILUA request from proponents. Many such negotiations are underway in the NQLC region. For major projects, a CHMA or CHMP is usually negotiated early, allowing native title groups to influence design and approvals. Early engagement has led to wind turbines being relocated, saving time and money. If you need assistance with proponents, contact the NQLC FAME Unit.

PBCSU TEAM UPDATE



The PBC Support Unit offers corporate support to the 32 Registered Native Title Body Corporates (RNTBCs) within the NQLC RNTB area. PBCSU is also assisting 3 native title claim groups to develop policies and establish their corporations to be the RNTBC upon a successful determination of their claim.

Rulebooks, Policies Reviews and Updates

PBCSU continues to assist PBCs in conducting comprehensive reviews of their rulebooks and policies. Currently, we are working with 4 groups to tailor policies and procedures to their needs as their corporations and operations have expanded. Two PBCs have replaced their rulebooks this year and another PBC has approached the PBCSU with a request to replace their rulebook to be compliant with the 2021 NTA Amendments Act. If you want to review your rulebook, or have not updated your rulebook since the 2021 NTA Amendments Act and want some assistance, please do not hesitate to contact the PBC Support Unit.

General Meeting Assistance

PBCSU has been requested to assist with 5 general meetings this financial year. The assistance requested is usually in the form of facilitating elections, providing an independent chairperson, providing legal advice, taking minutes and/or providing technical support. 
Planning
